## What's in a Draft Assessment?

The Bridger-Teton National Forest is currently in the assessment phase of revising its forest plan. Around 30 forest specialists are currently working on the draft assessment report. The draft assessment is the first step in the process to update direction of the forest plan and serves as a "status report" of the forest. The report will summarize existing ecological, social and economic conditions, and

trends affecting the forest. It is not a decision document, however, it will provide the foundation to determine what needs to change to improve guidance for forest management into the future.

A draft assessment report covers the following 15 topics:

- Terrestrial ecosysems, aquatic ecosystems, and watersheds
- Air, soil, and water resources and quality
- System drivers, including dominant ecological processes, disturbance regimes, and stressors, such as natural succession, wildland fire, invasive species, and climate change; and the ability of terrestrial and aquatic ecosystems on the plan area to adapt to change
- Baseline assessment of cabon stocks
- Threatened, endangered, proposed and candidate species, and potential species of conservation concern present in the plan area

- Social, cultural, and economic conditions
- Benefits people obtain from the NFS planning area (ecosystem services)
- Multiple uses and their contributions to local, regional, and national economies
- Recreation settings, opportunity and access, and scenic character
- Renewable and nonrenewable energy and mineral resources
- Infrastructure, such as recreational facilities and transportation and utility corridors
- Areas of tribal importance
- Cultural and historic resources and uses
- Land status and ownership, use, and access patterns
- Existing designated areas located in the plan area including wilderness and wild and scenic rivers and potential need and opportunity for additional designated areas.

Due to the length of the report, Bridger-Teton staff are working to make the document more readable and digestable for the public. Forest staff hope to have the draft assessment completed by fall 2024. At that time, the Bridger-Teton will plan to hold public engagement opportunities to formally release the draft assessment report to the public and begin a formal public comment period later in 2024.
