Ashley- Presented information about SRSC RAC program through a RAC refresher PowerPoint.

Sean also clarified the committee on the timeline for funding of the projects and explained they are made possible with shared stewardship. Also explained the structure of the of funding to Modoc County SRS Title II.

Project Proposals

1. Joseph Creek Water Source-Hommerding, Michelle

Develop a sustainable water source for grazing, fire suppression, road maintenance and other uses. Project would fund a USFS contract to drill and case a new well. USFS is pursuing additional funds for Phase 2 - power connection, pond, and pump.

Requested amount: \$120,000 for drilling and casement. Total is estimated at \$ 300,000. * Looking into conservative finances for funding alternate

2. Wildhorse Middle Section Spring Exclosures- Madeline Levy

Protect/exclude spring source/riparian areas severely impacted by wild horses. Build/install enclosure fencing. Protect vital spring sources to restore lentic/lotic functionality in the riparian system.

Requested amount: \$75,000.

3. Upper Cottonwood Creek Trail Project- Mefford, Joshua

Including directional signs, and tread work for the original trail corridor to the historic cabin. As well as the removal of a gabion basket that has failed on the Upper Cottonwood Trail. Along with the rehabilitation of the Upper Cottonwood Trail Project area.

Requested amount: \$75,000.

4. Pump Restore Project – Glenn Alan

Pump restoration- More details on the way

Requested amount: \$50,000.
