This description and the accompanying final map are based on the Congressionally approved 4.2-mile segment of the “South Fork Clackamas River” for the creation of the South Fork Clackamas River Wild and Scenic River contained within the Omnibus Public Land Management Act of 2009 (Public Law 111-11) dated March 30, 2009. This description and the accompanying final map shall govern all boundaries of the Wild and Scenic River and shall be considered as if contained in the original legislation, Public Law 111-11. In the case of any conflicts found between the final map and this description, the final map shall govern the resolution thereto.

The mapping base is the U.S. Forest Service (USFS) Land Status Record System and corporate data sets. Except where specified, all bearings, distances, elevations, and latitudes and longitudes in this document are derived from Geographic Information Systems data, based on the North American Datum of 1983 and the National Geodetic Vertical Datum of 1929. The latitudes and longitudes reported for certain corners and angle points in this description are provided to assist in the location of described features. Where called for, physical features will control over bearings and distances, and latitude and longitude.

Where the boundary is described as a topographic feature, the actual location of the feature will control the course identifying that part of said boundary. Where the boundary is described as an offset, the physical location of the feature is based on the location at the time of acceptance.

Wild Segment: “The 4.2-mile segment of the South Fork Clackamas River from its confluence with the East Fork of the South Fork Clackamas to its confluence with the Clackamas River, to be administered by the Secretary of Agriculture as a wild river.” (Public Law 111-11, Sec.1203(a) (1) (171))

A parcel of land, situated in the state of Oregon, County of Clackamas, and being a portion of the following sections (secs.) of the Public Land Survey System:

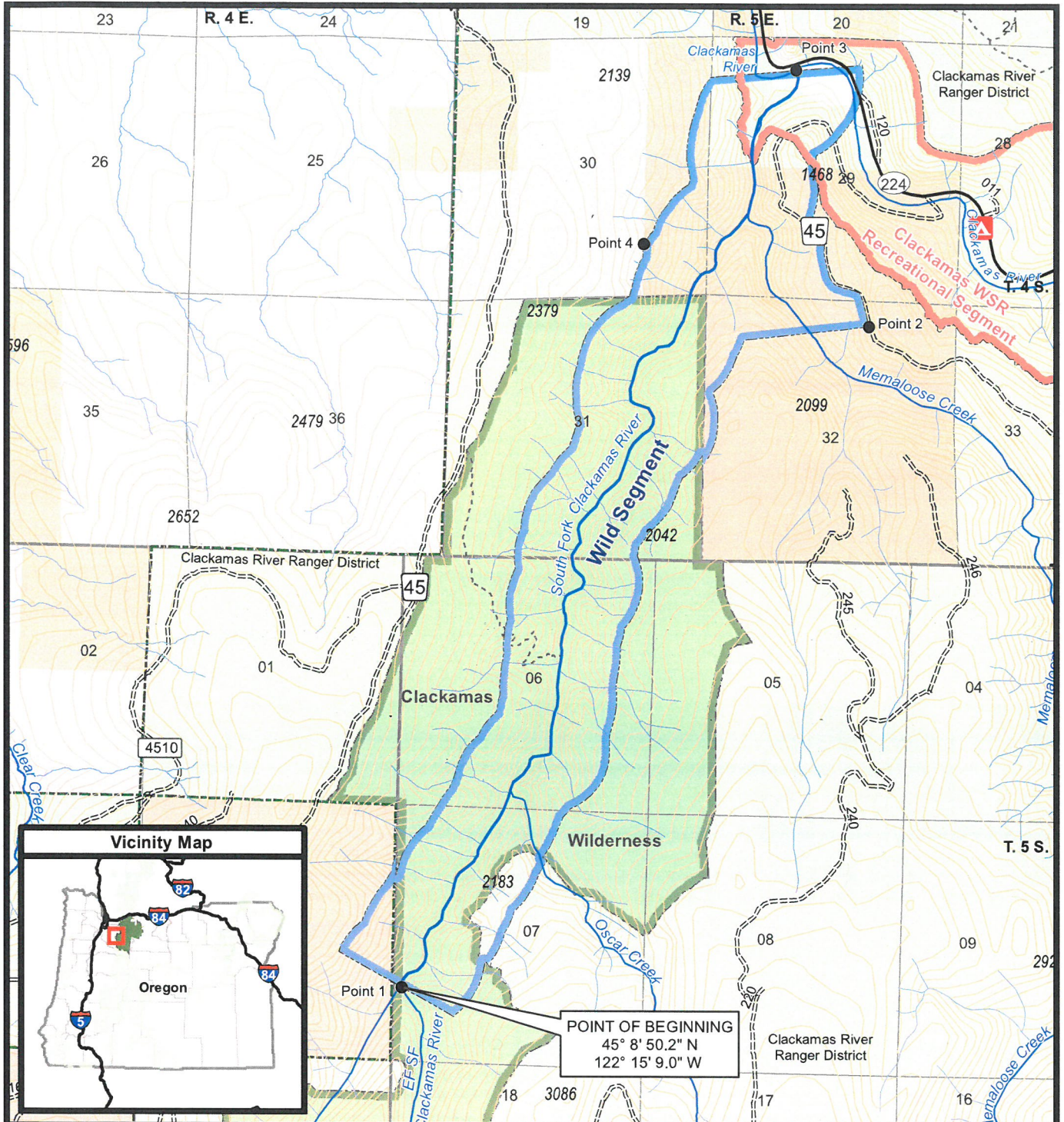
The parcel is bounded by the following described line:

BEGINNING at the confluence of the South Fork Clackamas River and the East Fork of the South Fork Clackamas River, said confluence being located at the approximate arc of latitude at 45°08'50.2" North and arc of longitude at 122°15'09.0" West. Said **POINT OF BEGINNING** is labeled "**Point 1**" on the final map. Thence from said **POINT OF BEGINNING**, the following 19 courses:

1. South 62°03' East, 1215 feet, more or less, to the line offset 1200 feet easterly of the easterly ordinary highwater line of the South Fork Clackamas River;
2. Northeasterly, along said offset, 1335 feet, more or less, to the true boundary of the Clackamas Wilderness, said intersection being located at the approximate arc of latitude at 45°08'55.8" North;
3. Southeasterly, along said wilderness boundary, 140 feet, more or less, to the line offset 1320 feet easterly of the easterly ordinary high water line of the South Fork Clackamas River;
4. Northeasterly, along said offset, 2495 feet, more or less, to the true boundary of the Clackamas Wilderness, said intersection being located at the approximate arc of latitude at 45°09'16.6" North;
5. Northwesterly, along said wilderness boundary, 125 feet, more or less, to the line offset 1200 feet easterly of the easterly ordinary high water line of the South Fork Clackamas River;
6. Northeasterly, along said offset, 1.78 miles, more or less, to a point on the line between sections 31 and 32, T. 4 S., R. 5 E.;
7. Southerly, along said section line, 235 feet, more or less, to the line offset 1320 feet easterly of the easterly ordinary high water line of the South Fork Clackamas River;
8. Northerly, along said offset, 2885 feet, more or less, to a point being located at the approximate arc of latitude at 45°11'03.6" North;
9. North 82°12' East, 2575 feet, more or less, to **Point 2** and the intersection of the center line of Forest Service Road No. 45 and the arc of latitude at 45°11'07.1" North;
10. Northwesterly, along said center line, 2605 feet, more or less, to the line offset 1320 feet easterly of the easterly ordinary high water line of the South Fork Clackamas River;
11. Leaving said center line, Northerly, along said offset, 3745 feet, more or less, to a point North 83°48' East of the confluence of the South Fork Clackamas River and the Clackamas River;
12. South 83°48' West, 1350 feet, more or less, to said confluence and **Point 3**;
13. South 83°48' West, 1770 feet, more or less, to the line offset 1320 feet westerly of the westerly ordinary high water line of the South Fork Clackamas River;
14. Southerly, along said offset, 3875 feet, more or less, to **Point 4**, a point on the north-south center line of the southeast 1/4 of section 30, T. 4 S., R. 5 E.;

15. Southerly, along said north-south center line, 275 feet, more or less, to the line offset 1200 feet westerly of the westerly ordinary high water line of the South Fork Clackamas River;
16. Southerly, along said offset, 2.71 miles, more or less, to a point on the line between section 12, T. 5 S., R. 4 E., and section 7, T. 5 S., R. 5 E.;
17. Northerly, along said section line, 440 feet, more or less, to the line offset 1320 feet westerly of the westerly ordinary high water line of the South Fork Clackamas River;
18. Southwesterly, along said offset, 2375 feet, more or less, to a point North 62°03' West of the **POINT OF BEGINNING**;
19. South 62°03' East, 1490 feet, more or less, to the **POINT OF BEGINNING**.

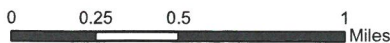
The area described, including both federal and non-federal lands, contains 1334 acres, more or less, and encompasses approximately 4.2 miles of the South Fork Clackamas River.
