**MT. HOOD ORDER No. 06-06-09-25-01  
Bull Run Watershed Management Unit Closure Order**

Pursuant to 36 CFR 261.50(a) and (b) the following acts are prohibited within all National Forest System (NFS) lands in the area known as the “Bull Run Watershed Management Unit” (BRWMU), as depicted in Attachment A and described below.

This Order will be effective for two years from the date it is signed; beginning March 13, 2025, and ending March 13, 2027.

**PROHIBITIONS:**

1. Going into or being upon the area which is closed for the protection of public health or safety. 36 CFR 261.53(e)
2. Being on a road. 36 CFR 261.54(e)
3. Being on a trail within the area described in Exhibit A., except to travel on the Pacific Crest National Scenic Trail #2000 and Huckleberry Trail #617. 36 CFR 261.55(a)
4. Building, maintaining, attending or using a fire, campfire, or stove fire, except for a pressurized liquid or gas stove. 36 CFR 261.52(a)

**CLOSURE AREA:**

This closure affects NFS lands in the sections listed below in the Willamette Meridian, Oregon within the boundary of the Bull Run Watershed Management Unit (BRWMU) in Clackamas and Multnomah Counties, Oregon. The public lands affected total approximately 89,306 acres:

**EXEMPTIONS:**

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this order:

1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
2. Owners or lessees of land within the area.
3. Any Federal, State, or local officer, or member of any organized rescue or fire fighting force in the performance of an official duty.
4. Persons engaged in specifically authorized business within the area.

These prohibitions are in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A. Violations of this prohibition are punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both (16 U.S.C. § 551; 18 U.S.C. §§ 3351, 3559, 3571, and 3581).
