FOREST ORDER NO. 06-22-01-21-14
Overnight Use and Large Boat Launch Prohibition

Pursuant to 16 USC § 551 and 36 CFR 261.50(a) and (b), and to provide for public safety and the protection of natural resources, the following acts are prohibited in the Columbia River Gorge National Scenic Area lands within the State of Washington as shown on the attached Exhibit A. This Order rescinds and supersedes Forest Order 06-22-01-21-08, signed on July 2, 2021 by Donna Mickley. This Order is effective November 2, 2021 and will remain in effect until rescinded.

Prohibitions

- 1. Camping** (36 CFR 261.58(e))
- 2. Parking or leaving a vehicle in violation of posted instructions** (36 CFR 261.58(g))
- 3. Launching of large boats, defined as those that cannot be hand carried to the water and/or require a trailer for transport** (36 CFR 261.58(r))

Description of Prohibitions

As depicted on "Exhibit A" the following acts are prohibited on all National Forest System (NFS) lands at Klickitat Mile One, within the Columbia River Gorge National Scenic Area (T. 3N R. 12, Sections 34 and 35, Willamette Meridian) and Klickitat County, Washington:

- Overnight use of the Klickitat Mile One recreation site including camping or leaving a vehicle at the site overnight.
- The launching of large boats (defined as those that cannot be hand carried to the water and/or require a trailer for transport).

Exemptions

Pursuant to Title 36 CFR 261.50(e), the following persons are exempt from this order:

- (1) Any person with a permit specifically authorizing the otherwise prohibited act or omission.
- (2) Any Federal, State, or local official or member of an organized rescue or firefighting force in the performance of an official duty.
- (3) Any person conducting Forest Service administrative work through an authorized contract or agreement.
- (4) Any member of the Yakama Nations with proper Yakama Nations identification that is exercising Tribal Treaty Rights.

Violation(s) of this (these) prohibition(s) are punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both (16 USC § 551; 18 USC §§ 3551, 3559, 3571, and 3581).

Exhibit A

Klickitat Mile One

Legal Description: T.3 N., R.12E, Section 34 & 35

Longitude: -121.280313 Latitude 45.703483

Klickitat Mile One is in Klickitat County approximately one mile north of Lyle, Washington on National Forest System lands within the Columbia River Gorge National Scenic Area. Klickitat Mile One is also located within the Lower Klickitat Wild and Scenic River corridor. The forest order encompasses lands and shorelines west of the Klickitat Trail to the shoreline in the NE section of T.3 N., R.12E 34 with the point of beginning (POB) at $\frac{3}{4}$ of the way down Klickitat County Park Road. From $\frac{3}{4}$ down the Klickitat County Park Road the northern boundary of the forest order runs west to the shoreline (marked by county boulder line) and east of the road to the west side of the Klickitat Rail Trail. The order encompasses all lands and shoreline from the northern border, just described, and from the west side of the Klickitat Rail Trail to the shoreline to Lat 45.702339°, Long: -121.283233° just beyond the peninsula. An additional segment of the closure begins on the east side of the Klickitat Rail Trail in T.3 N., R.12E 35 to a diagonal line one half the distance between Klickitat County Park Road and the Klickitat Rail.
