Monongahela National Forest – West Virginia

Monongahela National Forest was established April 28, 1920, and is in the Allegheny Mountains of eastern West Virginia. The Forest includes more than 920,000 acres of federal land in ten counties and the headwaters of six major river systems. Located within a day's drive of nearly half the nation's population, with an estimated average visitation of 500,000 annually, the Forest is one of the most biologically diverse national forests in the United States, partially due to variations in elevation and precipitation. The lowest part of the Forest is about 1,000 feet above sea level, while the central portion of the Forest contains the state's highest point, Spruce Knob, at 4,863 feet. Monongahela National Forest is a working forest, providing timber, water, grazing, minerals, fish and wildlife habitat, along with recreational opportunities for current and future generations.
