Recreation Fee Program Accomplishment Highlights 2021

Campground drinking water systems, that were installed in the 1960's, are continuing to keep USFS recreation employees busy with replacing and repairing parts. This year, the entire hand pump was replaced at McBride Springs Campground and a new concrete platform was constructed to meet current standards and requirements. The new hand pump is so much easier for the public to use. Recreation fee revenue in the amount of \$5,000 covered the cost of the project.

Recreation Fee Dollars

Recreation fee dollars are an investment in outdoor recreation. They support and enhance:

- Recreation site maintenance and improvements
- Educational experiences
- Informational wayside exhibits
- Youth programs and partnerships
- Interpretive programs

Current and future generations benefit as 80-95% of the funds are reinvested in the facilities and services that visitors enjoy, use, and value.

Forest Glen Rental Cabin

The total cost of the project was approximately \$7000. The rotten exterior siding was replaced in kind. The building was pressure washed and then painted. New screens were constructed for the windows. The interior was painted, and wood paneling was reconditioned. New grip was added to the front porch decking to reduce slip hazards. The water storage tank was replaced.

Other Accomplishments

- Repaired approx. 1 mile of NFS road (rock/grading) that leads to the Clear Creek TH: main climbing route for 2021.
- Replaced multiple wilderness/climbing trailhead signs.
- Conducted SAR operations on Mount Shasta
- Renovated Camp 4 Group Use site with new campsite spurs, kiosk replacement, and group fire ring.
- Patrolled and educated visitors about regional forest closures due to extreme wildfire conditions.
- Maintained all REA sites to health and safety standards
