## Recreation Fee Program Accomplishment Highlights 2021

### Boating on the Tuolumne River

River rangers expanded the Meral's Pool Boat Ramp. Crews set grade, installed concrete forms and steel, and poured the concrete to extend the ramp. The ramp was widened by eight feet to make it a total of 22 feet wide by 80 feet long. Crews also added two staging pads on the downstream side. Additionally, the crew repaired the Cherry Creek run slide put-in as a slope stabilization project by pining and concreting a boulder that threatened the integrity of the Cherry Creek Boat Ramp.

Rangers continued their assistance to rafters with wrapped boats and emergency evacuations. They conducted outfitter and guide permit inspections and initiated riparian revegetation, restoration on the Main Tuolumne and removed navigation hazard trees blocking the Tuolumne above the confluence with the South Fork Tuolumne.

All this work was completed using recreation fee funds from river users.

### The Realities of Trash

The Forest Service provides refuse dumpsters at certain campgrounds to protect wildlife. Despite signage not to leave trash out and Forest Service campaign to *Pack it in and Pack it out*, much trash is left around full dumpsters.

Unfortunately, rangers need to spend precious time cleaning up the mess, leaving less time to focus on important tasks such as checking on abandoned campfire and restroom

cleaning throughout all the campgrounds. Recreation fee funds contribute to staff insuring a safe environment for the public and wildlife.



## Other Accomplishments

- Everyday recreation fee collection and reconciliation and fee compliance
- Supported campground hosts at high user visitation sites.
- Installed, repaired and maintained campground bollards, fire rings, and signs.
- Cleaned campgrounds and toilet facilities daily.
