Pursuant to 36 CFR § 261.50 (a) and (b) for the protection of public health and safety (36 CFR § 261.53 (e)) following Tropical Storm Helene, the following acts are prohibited on the Appalachian Ranger District of the Pisgah National Forest. This closure is effective until 10/01/2025 or until rescinded by an authorized Forest Service official, whichever occurs first.

- 1. Entering or using developed recreation sites listed below 36 CFR § 261.58(b)
- 2. Going into or being in the described closure area. 36 C.F.R. § 261.53(e)
- 3. Being on a National Forest System trail listed below 36 CFR § 261.55(a)
- 4. Using a motor vehicle on a National Forest System Road listed below 36 CFR § 261.54(a)
- 5. Use by any type of traffic (motorized, pedestrian, bicycle, etc.) and/or being on a National Forest System Road listed below 36 CFR § 261.54(b)(e)

Under 261.58(b), the following closed developed recreation sites have been identified:

Murray Branch Picnic Area Stackhouse Boat Launch Black Mountain Campground Briar Bottom Campground Poplar Boat Launch Carolina Hemlocks Campground Roan Mountain Recreation Area

### **Described Closure Areas, Roads, and Trails**

The described closure areas are within Buncombe, Haywood, Madison, Mitchell, and Yancey Counties and include all NFS lands within the following boundaries:

### Shope Creek:

All National Forest Lands within the Forest boundary surrounding the Shope Creek drainage. This closure area includes the following roads:

### **Big Ivy and South Toe:**

The closed area is described as all National Forest Lands within the following boundary: Beginning at the junction of State Highway 19E and State Route 226 near Spruce Pine, NC, follow State Route 226 south to the Blue Ridge Parkway. Continue west on Blue Ridge Parkway to State Route 694 near Craven Gap Trailhead. Proceed southwest on State Route 694 to Interstate 40. Continue west on Interstate 40 to State Highway 25 and proceed north to Interstate 26. Continue north on Interstate 26 to State Highway 19 near Mars Hill, NC and proceed east on State Highway 19/19E to the junction with State Route 226 at Spruce Pine, NC. This closure area includes the following roads and trails:

Under 261.50(b), the following activities are prohibited: Use by any type of traffic (motorized, pedestrian, bicycle, etc.) and/or being on a National Forest System Road listed below - 36 CFR § 261.54(b)(e):




- 1. Persons with a special use permit or contract specifically authorizing the otherwise prohibited act of omission.
- 2. Any Federal, State, or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
- 3. Owners or lessees of land in the area are exempt from road closures that access property.
- 4. Residents in the area are exempt from road closures that access residence.
