Sanders County Resource Advisory Committee Meeting Notes 09/30/2020

I. Call to Order, Agenda Review and Committee Update

Robin reviewed the agenda and provided opportunity for DFO to share opening comments.

3 representatives were present from each category, so a quorum was present.

II. Elect Chair & Review/Approval of Previous Minutes

Carol Brooker went on record at the 9/23/2020 meeting nominating Colleen McCarthy as chair for the committee. Robin verified that this motion still stands.

Robin agreed to continue to facilitate tonight's meeting but would follow up with Colleen on how future meetings will be handled.

Robin emailed out the previous 2 meeting minutes directly to members on 9/28/2020 for review.

III. Project Ranking Review & Discussion

Robin received all but 3 members ranking sheets prior to the meeting. The 3 missing were the members not present at the meeting. All ranks were compiled, and the overall rankings were provided to committee members via screen sharing. Robin reviewed the following information with members:

- A total of \$240,004 funds are available.
- Based on initial rankings the money would stretch to 14 projects, but not fully fund the Plains/Thompson Falls RD RAC Proposal Weed Treatment project. This project would only receive \$24,262.20 of the \$29,646 requested if no changes were made.
- Robin noted that projects 2 & 3 as well as 9 & 10 had same overall ranking. Committee was not concerned with this since all these projects were above the funding line.

Committee Discussion:

- Kevin M. inquired about whether or not any of the projects below the funding line were likely to receive GAOA funding. Erin discussed that there were a lot of deferred maintenance projects submitted for GAOA funding, but projects like those below the funding line here were not rating out high to receive GAOA funds this next year.
- Randy H. noted that the Cabinet Ranger District Youth Conservation Corps Crew project is above the funding line but is actually for the 2022 season. He stated he is a proponent of the YCC programs, but just wanted folks to be aware that this is not a project that will be implemented in 2021, but instead the money would be in the bank for the following year.
 - Several others contributed thoughts as to whether it makes sense to adjust this rating or not. All agreed that the YCC is one of the favorite projects, but since it is an out year project perhaps the ranks could be adjusted. Carol provided some information regarding the status of out year SRS funds. Heather discussed opportunities for the RO to provide out year YCC funds.
 - Ultimately the group decided to leave the ranking as is and not chance this program not receiving funds the following year.
- Several folks discussed that they really wanted to see the eDNA project receive some funding, but it rated out at #18.
- Karen Sheets mentioned that the Kootenai road projects would not receive any funding this round if the rankings stay as is.
 - O John Errecart offered his thoughts on his approach to rankings this round. He stated that he looked at the repeat projects that were submitted this spring that already received funding and rated them lower in order to share the wealth to some other program areas this round. All of these projects are good, and all the programs could use the additional fiscal support.
- Motion made to fund 50% of the requested amount of the Aquatic eDNA Sampling on the Cabinet Ranger District. The money would be pulled from project 14, Plains/Thompson Falls RD RAC

Proposal-Weed Treatment. The eDNA project would receive \$8085, and the Weed Treatment project would receive \$16,177.

- Motion made to approve the overall rankings of all 21 projects, as modified with the adjustment listed above to the funding levels.

- As ranked, the 50% requirement would be not quite be met for this round of projects. This round of rankings resulted in 47% of funding that would be applied to projects that are primarily dedicated to road maintenance, decommissioning, obliteration or restoration of streams and watersheds. The last round was at 71%, so overall the group has still met the 50% requirement.

- Ron inquired about how well received the Fee increases have been by the public. Heather responded stating that the official increases have not yet been implemented. Some will go into effect with the new fiscal year, but the seasonal rentals will not go into effect until they open next spring/summer.
