

Mt. Baker-Snoqualmie National Forest

Watershed Management Strategy

The Mt. Baker-Snoqualmie National Forest (MBS) has developed a watershed-based planning strategy to provide an efficient NEPA review and decision-making process for the MBS. The purpose of this effort is to move the Forest toward the desired future conditions as laid out in the MBS and Northwest Forest Plans. This approach takes the guesswork out of planning and provides opportunities for aligning projects with Tribes, partners and stakeholders.

With this strategy, the Forest can sustain two large-scale NEPA projects simultaneously, one on each zone. The goal is for planning teams across the MBS to process each watershed in their zone using a 2-year planning cycle that includes up to 12 months of pre-planning and data collection followed by 12 months of NEPA (from Scoping to Decision).

There are several reasons for taking a different approach to our planning. The Forest needs a strategic approach that will achieve and communicate outcomes for integrated projects. We want to identify a path forward that allows Tribes, partners, and the public to know when and where we will be analyzing projects. Additionally, this approach will allow us to lay out realistic expectations for completing NEPA, identifying funding sources, and ensuring investments are made at the right time.



Prioritizing Watersheds

The MBS contains approximately 35, 5th level watersheds. Based on ecological modeling that included the location of plantations in need of restoration (60-80 years old), data from the Puget Sound Watershed Restoration modeling, and road and stream interactions that are most sensitive to climate change, the watersheds were ranked in priority order across the north and south zones. The results of this modeling formed the basis of our strategic watershed planning. Where needed, watersheds were combined to assist in the planning process. Below are the five priority watersheds that have been identified for planning and project development.

- 2024 Carbon River on the Snoqualmie RD (pre-planning begins in 2024 with NEPA in 2025)
- 2025 Baker River on the Mt. Baker RD
- 2026 Lower and Upper Sauk River on the Darrington RD
- 2027 Middle Fork Snoqualmie River on the Snoqualmie RD
- 2028 South Fork Skykomish River on the Skykomish RD
