No RV or car camping</p> <p>-Campfires are not allowed if the state has issued a "Red Flag Warning"</p> <p>-Visitors may only use dead and down wood. No cutting of live or dead standing trees</p> <p>-You must be ½ mile from any road or parking lot before primitive camping with permit is allowed</p>
