Kisatchie National Forest Annual Trail Use Pass

This pass entitles you to unlimited trail use in special recreation permit fee sites or areas forest wide for one year from month of issue. Special recreation permit fee sites or areas in the Kisatchie National Forest (KNF) include designated multiple-use trail systems established for use by OHV riders, hikers, horseback riders and mountain bikers.

Special Recreation permits are issued as a means to ensure extra measures are required for natural and cultural protection, the health and safety of visitors, or to allocate capacity and/or disperse recreation use.

This pass is part of the Federal Lands Recreation Enhancement Act, approved by Congress in 2004. Your fees stay in the Kisatchie National Forest to help maintain and improve the recreation areas you enjoy. Your money may be used to upgrade facilities, improve information and customer service, and provide interpretation and environmental education. Please let us know what improvements you would like to see!

What is covered:

This annual trail use pass is honored at special recreation fee sites or areas operated by the Kisatchie National Forest.

What is NOT covered:

- Fees for overnight use.
- Fees to reserve a picnic pavilion.
- Fees in other national forests across the United States.
- Some areas run by private concession that do not participate.

What are the benefits?

Unlimited visits to special recreation permit fee sites/areas, forest-wide, for one year from month of issue. No filling out individual fee envelopes, no worries with correct change. The Annual Trail Use Pass is designed to save money for the frequent forest visitor.
