PROOF OF PRINCIPAL RESIDENCE

In order to be in compliance with the current Special Use Permit terms and conditions, you must provide proof of Principal Residence.

The Special Use Permit on page one (1) states, the holder "...is hereby authorized to use National Forest lands, for a recreation residence for personal recreational use on the Shasta-Trinity National Forest..." The Permit on page two (2) further states:

"PROHIBITION ON FULL-TIME OCCUPANCY. The permitted improvements shall not be used as a full-time residence. Use of the permitted improvements as a principal place of residence is prohibited and shall be grounds for revocation of this permit."

The Region 5 Forest Service Handbook Recreation Residence Supplement 2709.11-2011-2 defines **"Principal Residence"** as follows:

"A principal residence can be a house, apartment, mobile home, or other reasonable domicile, either owned or rented, and must be open and available to the permit holder at all times. The principal residence cannot be simply an address used to give the appearance of living in a home elsewhere. It must be the place where the permit holder routinely received mail, is registered to vote, from which children attend school, and from where the permit holder normally commutes to work."
