How to Use This Form

The following form is not a valid permit! This form is for permit application only. Use the form by filling in the boxes below and returning the completed form via email to SM.FS.arpforprod@usda.gov. Once our office receives your form, you will be contacted via phone by Forest Service staff to process a credit card payment for the official permit. Once payment is received, a permit will be emailed to you with a Forest Service staff signature. The permit must then be printed, signed by the permit holder, and carried – filling out the "Product Quantity Removal Record" section of the permit as you cut; should a law enforcement officer need to check your permit and load.

Please Note

Forest Product permit regulations and application differ from forest to forest. Below highlights important difference to take note of:

This Form – Use the form below to apply for a Forest Product permit, by sending the completed form to SM.FS.arpforprod@usda.gov.

Signatures - The permit holder is responsible for printing and signing your Forest Product permit, which will be emailed once payment is received.

Load Tags – The permit holder will be responsible for carrying the printed, signed copy of their permit, and filling out the "Product Quantity Removal Record" as they cut. This will be taking the place of "Load Tags" should a Law Enforcement Officer need to check the load.

Closure Areas – Several locations throughout the forest remain closed to all users because they are within burned areas. It is the permit holder's responsibility to observe closure area boundaries. To check closure area status please visit: https://www.fs.usda.gov/r02/arp/alerts.

POST & POLE PERMIT

A valid permit is required for cutting and collection of up to 20 live/dead post & poles per issued unit (CCF) on public system lands only on the Sulphur Ranger District of the Arapaho and Roosevelt National Forests (FS2400-1). WOOD PRODUCTS OBTAINED UNDER THIS PERMIT IS FOR PERSONAL USE AND MAY NOT BE RE-SOLD TO OTHERS.

RULES FOR CUTTING & REMOVING WOOD

The following rules must be read and agreed to before a permit will be issued:

- This sale is final and payments are not subject to refund.
- A printed physical permit must be in permittee's possession and kept readily available while harvesting and transporting products. A copy on a mobile device is not acceptable and multiple reproductions of this permit are not allowed.
- Privately Owned Lands and State in-holdings within National Forest boundaries are closed to harvest. The boundaries between
 private/state lands and federal lands are not always marked. It is your responsibility to know where you are harvesting at all
 times.
- This permit allows for the cutting and gather under the following conditions:
 - a. ONLY LIVE/DEAD LODGEPOLE PINE TREES, ALL OTHER STANDING DEAD TREES, AND/OR DOWNED TREES CAN BE COLLECTED UNDER THIS PERMIT.
 - b. MATERIAL CUT AND/OR COLLECTED UNDER THIS PERMIT SHALL BE NO GREATER THAN 7 INCHES IN DIAMETER AND SHALL BE CUT INTO LENGTHS OF 16 FEET OR LESS PRIOR TO REMOVAL FROM NATIONAL FOREST SYSTEM LANDS.
- Closure orders may change throughout the year and may not be displayed on the permit map. Permit holder is responsible for observing all official road and area closures.
- Motorized vehicles are not allowed off existing roads that are open to the public, unless otherwise specified within this permit.
 Permittee parking shall not block traffic or impede fire or emergency vehicles.
- ALL motorized vehicles must stay on system roads and are NOT allowed off roads to assist in collection; however, wood may be transported using carts or wheel-barrows to transport material from the Forest to your vehicle.
- No tree felling within 125 feet of power lines. Do not cut any trees marked with paint. Do not cut bearing trees, trees that identify private property, or trees near land survey monuments (i.e.; brass cap locations).
- Do NOT fell trees onto any road. All trees shall be felled away from roads, and not onto road surfaces or within road ditches.
- Posts and Poles may NOT be cut or gathered in commercial contract project areas as identified on the map, within wilderness areas, or within 500 feet of developed recreation sites including campgrounds, picnic areas, summer home groups, or trailheads.
- Cut stumps to a 6 inch height or less.
- Remove all slash and other uncollected material from roadway surfaces, ditches, culverts, trails and stream channels by
 scattering back into the forest. Any slash and other uncollected material shall be scattered at a depth not to exceed 12 inches
 above the ground.
- Do not smoke in the gathering area.
- Permittee shall remove all trash and litter resulting from permittee's activities.
- The Forest Service and/or BLM reserve the right to unilaterally revoke this permit for permittee's noncompliance with its terms and conditions or when revocation is in the public's interest.
