

# FOREST PRODUCTS REMOVAL REQUEST

## Arapaho And Roosevelt National Forests U.S. Department Of Agriculture - Forest Service

### How to Use This Form

The following form is not a valid permit! This form is for permit application only. Use the form by filling in the boxes below and returning the completed form via email to [SM.FS.arpforprod@usda.gov](mailto:SM.FS.arpforprod@usda.gov). Once our office receives your form, you will be contacted via phone by Forest Service staff to process a credit card payment for the official permit. Once payment is received, a permit will be emailed to you with a Forest Service staff signature. The permit must then be printed, signed by the permit holder, and carried – filling out the “Product Quantity Removal Record” section of the permit as you cut; should a law enforcement officer need to check your permit and load.

### Please Note

*Forest Product permit regulations and application differ from forest to forest. Below highlights important difference to take note of:*

**This Form** – Use the form below to apply for a Forest Product permit, by sending the completed form to [SM.FS.arpforprod@usda.gov](mailto:SM.FS.arpforprod@usda.gov).

**Signatures** – The permit holder is responsible for printing and signing your final Forest Product permit, which will be emailed once payment is received.

**Load Tags** – The permit holder will be responsible for carrying the printed, signed copy of their permit, and filling out the “Product Quantity Removal Record” as they cut. This will be taking the place of “Load Tags” should a Law Enforcement Officer need to check the load.

**Closure Areas** – Several locations throughout the forest remain closed to all users because they are within burned areas. It is the permit holder's responsibility to observe closure area boundaries. To check closure area status please visit: <https://www.fs.usda.gov/r02/arp/alerts>.

### TRANSPLANT PERMIT

A valid permit is required to collect transplant trees or shrubs for personal use on National Forest lands within the Arapaho and Roosevelt National Forests on the specific Ranger District indicated on the attached signed permit (FS2400-1).

### RULES FOR TRANSPLANTS

The following rules must be read and agreed to before a permit will be issued:

- This sale is final and payments are not subject to refund.
- Privately Owned Lands and State in-holdings within National Forest boundaries are closed to harvest. The boundaries between private/state lands and federal lands are not always marked. It is your responsibility to know where you are harvesting at all times.
- A printed physical permit must be in permittee's possession and kept readily available while harvesting and transporting products. A copy on a mobile device is not acceptable and multiple reproductions of this permit are not allowed.
- Closure orders may change throughout the year and may not be displayed on the permit map. Permit holder is responsible for observing all official road and area closures.
- Transplants may NOT be gathered in wilderness areas, developed recreation sites including campgrounds, picnic areas, summer home groups, or trailheads.
- All trees removed must be within 12 feet of another living tree. Do not remove if another tree is further than 12 feet away.
- The maximum allowable size for aspen transplants is 1" diameter measured at breast height (4.5') but no greater than 15 ft in height. Aspen trees with a root collar diameter of 3" or greater will be counted as two trees against the cutting limit. For all conifers, the maximum allowable height is 5 ft.
- Tree must be hand dug only. Machine digging is prohibited. Holes from removed trees shall be refilled with surrounding dirt and be level with the ground surface.
- No digging is allowed within 50 feet of perennial streams or main forest and county roads.
- Do not smoke in the gathering area.
- Permittee shall remove all trash and litter resulting from permittee's activities.
- The Forest Service and/or BLM reserve the right to unilaterally revoke this permit for Permittee's noncompliance with its terms and conditions or when revocation is in the public's interest.
