Cedar Creek Rifle Range is a free, self serve range which accommodates targets at 25, 50, 75 and 100 yards. Three of the five shooting tables are under a shelter.

Visitors from the Cassidy Bridge Hunt Camp can reach the range in only ten minutes. It is an easy place to practice target shooting while staying in the camp.

Site Information: five shooting tables; three under a shelter.

Note: the range is CLOSED Monday – Wednesday, but will remain open when Monday is a federally observed holiday.

Surrounding Area: Rich Mountain Rd, a scenic Forest Service road, is a nearby pleasant drive. Cassidy Bridge Road provides access to the trout stocked Chauga River and the Cassidy Bridge Hunt Camp.

Directions: From Whetstone Rd take a left onto Cassidy Bridge Rd. Remain on Cassidy Bridge Rd to the rifle range sign at Forest Service Road 726, turn left and follow dirt road back to the range.

Regulations:

*Tracer, incendiary ammunition or exploding targets are prohibited.

*Only stationary paper or manufactured targets mounted on self-provided stands or holders. Using bottles, cans, pumpkins, watermelons etc. or trash as targets is prohibited.

*Pack it in, pack it out. Shooters are responsible for own cleanup of all bullet casings, target and target holder and litter-trash. This includes all pieces of stationary, biodegradable skeet being used as a target.
