


All other Forest Plan components including Desired Conditions (Goals), Objectives, Standards, Guidelines and Suitability of Areas remain in effect and unchanged (Forest Plan at 13-14).

<p>The range section on page 660 of FEIS volume II of the FEIS states 281,999 acres are suitable for cattle under Alternative P, as does Appendix G (Description of the Analysis Process and Supporting Information) in FEIS vol. III (page 1325). The capability and suitability analysis were re-done after completion of the objection resolution meetings. See the July 23, 2019 Updated Final Range Report which shows 281,999 acres suitable for cattle grazing. The suitability acres in the hydrology and soils reports reference the earlier version and are not correct. The acres did not get updated in the final versions of the Hydrology and Soils reports (Hydrology Report 1/17/2018 Updated Final Hydrology Report and Soils Report 3/6/2017). Change in the FEIS are tracked in the redline version online. Changes to supporting specialist reports are not tracked in a redline version at this time.</p>
