12	Power Head: Minimum 67 cubic centimeters (cc) or larger. (D.2.1)		
13	Chainbrake: Functional (D.2.1)		
14	Spark Arrester: Operational approved spark arrester. (D.2.1)		
15	Maintenance Tools: Supplies, and parts to keep the saw operating in a safe and efficient manner (i.e. bar or saw tool, files, chain, gas/oil, etc.) (D.2.1)		
16	Other Equipment: Wedges <input type="checkbox"/> Falling Axe <input type="checkbox"/> (D.2.1)		
17	Vehicle: MUST be 4-wheel or all-wheel drive capable. (D.2.2)		
18	Vehicle: Capable of carrying all saws, hazardous materials (i.e. fuel/oil) external from passenger compartment (D.2.2)		
19	Seat Belts: Available and used by every passenger in any vehicle while in motion. (D.2.2)		
20	Spare tire: Full size spare with 4/32 minimum tread depth and easily accessible (D.2.2.2)		
21	Fire Extinguisher: 2A 10BC, that is securely mounted to the vehicle and accessible by the operator. The fire extinguisher shall have a current annual inspection tag. (D.2.2.4)
