4	Incident Pre-Use Inspection Completed (OF-296 Vehicle/Heavy Equipment Mechanical Inspection) (D.17)(D.17.1)		
5	Operators: 2 skilled operators present at all times during incident operational periods. (D.2.1.1)		
6	Required PPE: Eye protection, one pair, hearing protection. (D.2.1)		
7	Record: Daily record of all washed vehicles. (D.2.1)		
8	Self-contained with Recycling Water System: Waste water shall be contained within the system. (D.2.1.1)		
9	Berms or Barriers: Shall be a minimum of 4" on all sides. (D2.1.1)		
10	Portable Commercial Power Washers: 2 each, hand-held, high pressure wands/nozzles. Nozzles must be suitable to wash all surfaces of the vehicle or equipment that contain soil, mud, caked dirt, plant parts, seeds, and vegetative parts. (D.2.1.1)		
11	Underbody Washer: Must provide water spray at such an angle to ensure complete coverage of underbody surfaces and must be suitable to wash all underbody surfaces that contain soil, mud, caked dirt, plant parts, seeds, and vegetative parts (D.2.1.1)		
12	Wash Water Storage Tank: Adequate capacity to operate system for a minimum of 2 consecutive hours. (D.2.1.1)		
13	Waste Water: Contained by the wash system. Wash residues shall be removed from the tracking surfaces of all Incident vehicles being washed before the vehicle exits the system to prevent recontamination to exiting vehicle. (D.2.1.1)		
14	Entrances/Exits: Wash residues shall be contained so that the washed vehicle does not track removed residue or push down berms containing contaminants from the weedwash containment station at the entrance and exit of the system. A flat mat that allows a vehicle to roll through washed residue is not allowed. (D2.1.1)		
15	Filtering: Wastewater shall be filtered to a 100-micron particle size or less or use a clean water final rinse. (D.2.1.1)		
16	Solid Waste Containment Packages/Devices: Labeled and Secured, not to exceed 50 lbs. per package/device (D.2.1.1)		
17	Disposal of Solid Waste: Who is responsible: GOV/Host Agency <input type="checkbox"/> Contractor <input type="checkbox"/> Location of Designated Disposal Site: _____ (D.2.1.d)

18	Wash Time: Process time to wash a single fire engine shall not exceed 5 minutes (i.e. 12 engines per hour) (D.2.1.1)	
19	Wash System: Accommodates equipment up to 10 feet wide (D.2.1.1)	
20	Lights: Minimum of two 1,000 watt, or equivalent, work lights on stands with GFI module (D.2.1.1)	
21	OSHA Requirements: Electric Motors --All alternating current electric motors shall be list with Underwriters Laboratory (D.2.1.1)	
22	Weed Wash Operators are visually and manually inspecting hard to reach areas to ensure they are thoroughly washed and cleaned.
