The Nez Perce-Clearwater National Forests is making the following administrative changes to the 2025 Nez Perce-Clearwater National Forests Land Management Plan:

- Page 7 add "diversity" to the last sentence of the first paragraph under Ecological Diversity, to complete the reference to the Glossary for "ecosystem diversity".
- Page 39 Change "Guideline FW-GL-FIRE-03" to "Guideline FW-GL-FIRE-04" in the last paragraph on this page.
- Page 53 Change "FW-STD-ARLND-04" to "FW-STD-ARLND-03" in the first paragraph at the top of the page.
- Page 56 Within FW-STD-CWN-01, replace "Watershed" with "watershed".
- Page 97 In Table 30, replace "MA2-SUIT-DWSR-07" and "MA2-SUIT-DWSR-08" with "MA1-SUIT-DWSR-07" and "MA1-SUIT-DWSR-07".
- Page 111 In Table 39, replace the superscript "2" with "3" in the table and replace the reference to superscript 2 with "Except in the following current allotments: Buckner, Cedar, and Musselshell."
- Land Management Plan Appendices, Appendix 2, Page 46 remove the second glossary entry and definition for "Scenic Integrity Objective".
- Land Management Plan Appendices, Appendix 4, Page 138 remove "Ecosystem Component" from the heading and replace it with "Fire Management".
- Land Management Plan Appendices, Appendix 4, Page 169 remove "These desired conditions" from the first paragraph.

The purpose for these changes is to make corrections for accurate references to definitions, plan components, terminology, and remove an unfinished sentence (pp. 7, 35, 53, 56, 97, Appendix 2, p. 56, and Appendix 4, p. 169). The purpose of the administrative change on page 111 in Table 39 is to accurately reflect the suitability of livestock grazing within the Lolo Trail National Historic Landmark.

The administrative change does not change desired conditions, goals, objectives, standards, guidelines, or suitability determinations in the land management plan or where such direction applies. The administrative change does not change the monitoring plan.

The administrative changes are provided below and will be effective on August 11, 2025.

Purpose of Plan Component(s)

The desired conditions describe the characteristics of Riparian Management Zones that projects may strive to maintain or achieve, emphasizing the importance of these areas to stream function. Important indicators to consider are summer and winter thermal regulation, nutrient filtering, appropriate rates of surface erosion, bank erosion, and channel migration. In this case, the word "appropriate" is intended to be synonymous to those conditions that occur in reference watersheds, that are largely unaltered by human caused actions. A key concept is maintaining or achieving a range of riparian conditions in managed watersheds that is similar or the same as reference watersheds. These desired conditions
