## Dear interested party,

This letter is to notify you of an administrative change to the Willamette National Forest Land and Resources Management Plan. An error was found in the Forest-wide Standards and Guidelines for scenic resources (FW-059).

Table IV-24 of FW-059 was missing the visual quality objectives (VQO) for management area 3 and misattributed the VQO for management areas 2a, 5a, 9a, 9b, 9c, 10e, and 10d. To correct this error, Table IV-24 on pg. IV-56 is changed as shown below to match the standards and guidelines provided for each management area.
