

**Sierra NF 2027 Education and Safety**

**Draft Cost Estimate**

**Education and Safety 2027:**

The SNF designated trail system is over 190 miles of motorized trails. Primitive roads (ML2 or Green Sticker, 173 miles) are open for public access for motorized and non-motorized use. Motorized recreational experiences range from single track trails to challenging rock crawling to dirt roads. The difficulty of these routes range from easy to extreme routes throughout the system. The project area has 2,024 miles of roads open to all vehicles, including nonhighway green/red sticker vehicles, & 209 acres of designated areas open for recreational motor vehicle use or as a staging area for access to dispersed recreation opportunities. The aim of the following activities is to maintain & enhance OHV opportunities to Forest Service (FS) standards to provide the public with the best possible recreational OHV experience. The SNF winter program has 72,800 acres open to cross-country travel & 234 miles of snowmobile trails. These winter trails range from easy to most difficult. The difficult OSV trails access amazing vistas of the San Joaquin Valley, lakes & snowcapped ridges.

**Project Cost Estimate:**

Item	Cost for 2027
OHV Staff: Provide education, trespass prevention, and safety material while in official booth during OHV events and while present along OHV areas. Provide material while making public contacts. Speaking or presenting information and/or displays relating to OHV areas, rules, safety, and trail information at public fairs, events, on forest, and at the district office. Assist with signboard installations and signing. Help to set up official booth, displays, vehicles, and events. At schedule events present educational materials about ethical and responsible OHV riding and resource protection. Staff will emphasize staying on legal designated routes and avoiding trespassing on private property.	\$12,063
Forest Wide Specialist Support Staff: Funding to District Specialist, Aquatics, Botany, and Wildlife. Using data and information for the Forest Habitat Monitoring and Soil Conservation plans the specialist would prepare and present an overview of their findings. They will tie in how responsible riding will reduce or even prevent impacts from OHV use. Presentations may take place on the forest, classroom, or at local events.	\$3300

Ground Operations 2027:

The SNF designated trail system is over 190 miles of motorized trails. Primitive roads (ML2 or Green Sticker, 173 miles) are open for public access for motorized and non-motorized use. Motorized recreational experiences range from single track trails to challenging rock crawling to dirt roads. The difficulty of these routes range from easy to extreme routes throughout the system. The project area has 2,024 miles of roads open to all vehicles, including nonhighway green/red sticker vehicles, & 209 acres of designated areas open for recreational motor vehicle use or as a staging area for access to dispersed recreation opportunities. The aim of the following activities is to maintain & enhance OHV opportunities to Forest Service (FS) standards to provide the public with the best possible recreational OHV experience. The SNF winter program has 72,800 acres open to cross-country travel & 234 miles of snowmobile trails. These winter trails range from easy to most difficult. The difficult OSV trails access amazing vistas of the San Joaquin Valley, lakes & snowcapped ridges.

Through a combination of partnerships, volunteers, & various sources of funding, the Sierra National Forest (SNF) will undertake an OHV Ground Operations project that will include:

Maintain OHV trails and roads that allow OHV use (brush, remove logs, install and improve drainage structures, install and repair gates, repair tread, harden tread, maintain barriers to define trails, etc.) via Forest Service staff, Volunteers and Partners using hand tools, trail & road heavy equipment (i.e., Sweco trail dozers, skid steer with various attachments, stand behind loaders, mini excavators various attachments, full size dozers, excavators various attachments, backhoe, water trucks, and dump truck. Equipment is either already owned or will be rented for projects

- Maintain OHV open areas through specialized equipment.
- Acquire, install, repair and or replace OHV related signage.

Maintain OHV staging areas, trailheads, OHV campgrounds (clean and supply restrooms, litter pick-up, post and maintain kiosks/signs, pump vault toilets, maintain barriers to define parking areas, maintain/repair or replace picnic tables, fire rings, food lockers, hazard tree removal, repair vandalism, etc.).

- Monitors, reports, and mitigates OHV trail soil/hydrology conditions.
- Monitors, reports, and mitigates potential OHV impacts to sensitive plant and wildlife habitat, archaeological resources.
- Maintain and repair OHV equipment and trail tools.

Purchase supplies needed for Ground Operations functions (i.e., fuel for OHV equipment, trail hand tools, power tools, personal protective equipment, lumber, hardware, trail markers and decals, cleaning supplies, toilet paper, chainsaws, Tread Lightly materials, etc.)

### Project Cost Estimate:

Item	Cost for 2027
OHV Staff: Funding for staff to implement program of work on motorized routes. They will perform maintenance on OHV facilities, Green Sticker Roads, OHV designated trails. This work includes: Annual trail opening/clearing, maintaining trail corridor by brushing, sign installation, cleaning/repairing water bars and other erosion control structures, cleaning toilets, litter pick-up, and fire ring repair/cleaning. Trail Monitoring for trails and developed campgrounds for problems such as resource damage related to OHV use, implements projects for the mitigation of resource damage i.e. rock barriers, completes public contacts for implementation of MVUM, "Tread Lightly!" principles. Assist with on-site inspection of ground operation work.	\$556,000
Forest Wide Specialist Support Staff: Staff are responsible for completing reviews of OHV activities. When necessary, staff will provide guidance to assist OHV staff. Forest Specialist will produce required reports, Soil Conservation Plan and Habitat Monitoring Plan (HMP)	\$60,000
Forest Wide Road Crew Support: To assist primarily on Green Sticker Roads and when requested, OHV designated trails. Crew will use Forest Service equipment to maintain roads of importance to the OHV users. If OHV trails are accessible for the larger equipment, they will assist with trail repair and maintenance.	\$72,000
