

# FOREST PRODUCTS REMOVAL REQUEST

## Arapaho And Roosevelt National Forests U.S. Department Of Agriculture - Forest Service

### How to Use This Form

The following form is not a valid permit! This form is for permit application only. Use the form by filling in the boxes below and returning the completed form via email to [SM.FS.arpforprod@usda.gov](mailto:SM.FS.arpforprod@usda.gov). Once our office receives your form, you will be contacted via phone by Forest Service staff to process a credit card payment for the official permit. Once payment is received, a permit will be emailed to you with a Forest Service staff signature. The permit must then be printed, signed by the permit holder, and carried – filling out the “Product Quantity Removal Record” section of the permit as you cut; should a law enforcement officer need to check your permit and load.

### Please Note

*Forest Product permit regulations and application differ from forest to forest. Below highlights important difference to take note of:*

**This Form** – Use the form below to apply for a Forest Product permit, by sending the completed form to [SM.FS.arpforprod@usda.gov](mailto:SM.FS.arpforprod@usda.gov).

**Signatures** – The permit holder is responsible for printing and signing your Forest Product permit, which will be emailed once payment is received.

**Load Tags** – The permit holder will be responsible for carrying the printed, signed copy of their permit, and filling out the “Product Quantity Removal Record” as they cut. This will be taking the place of “Load Tags” should a Law Enforcement Officer need to check the load.

**Closure Areas** – Several locations throughout the forest remain closed to all users because they are within burned areas. It is the permit holder’s responsibility to observe closure area boundaries. To check closure area status please visit: <https://www.fs.usda.gov/r02/arp/alerts>

## FUELWOOD PERMIT

Forest Service Manual 2404.24 grants the Regional Forester the authority to sell and dispose of timber and forest products in the volumes and values shown in FSM 2404.28, Exhibit 01. This permit and activities hereunder are subject to all applicable Federal statutes and regulations and State and local laws. In case of conflict, Federal statutes and regulations shall take precedence. Where applicable, a Memorandum of Agreement between the Forest Service and BLM governs administration and enforcement of this permit (Sec. 330, P.L. 106-291).

## RULES FOR CUTTING & REMOVING WOOD

The following rules must be read and agreed to before a permit will be issued:

- This sale is final and payments are not subject to refund.
- This permit is valid to collect up to the number of cords specified on public system lands only on the Arapaho and Roosevelt National Forests.
- Privately Owned Lands and State in-holdings within National Forest boundaries are closed to harvest. The boundaries between private/state lands and federal lands are not always marked. It is your responsibility to know where you are harvesting at all times.
- This permit allows the cutting and gathering of wood within a distance of 200 feet of open roads on National Forest System lands only for the following conditions:
  - Standing red needled or gray pine trees and/or
  - Dead and down trees
- A printed physical permit must be in permittee's possession and kept readily available while harvesting and transporting products. A copy on a mobile device is not acceptable and multiple reproductions of this permit are not allowed.
- Closure orders may change throughout the year and may not be displayed on the Firewood Cutting maps. Permit holder is responsible for observing all official road and area closures.
- Firewood may NOT be cut or gathered on the Pawnee National Grassland, in commercial contract project areas as identified on the Where to Harvest maps, within wilderness areas, or within 500 feet of developed recreation sites including campgrounds, picnic areas, summer home groups, or trailheads.
- Do NOT cut or gather fuelwood from hand or machine piles unless authorized by a Forest Service Representative.
- All trees shall be felled away from roads, and not onto road surface or within road ditches.
- All chainsaws must be equipped with a spark arrester screen of at least .024-inch mesh. A shovel and one gallon of water must be immediately available for use in case of fire. Immediate access to a fire extinguisher is recommended.
- Motorized vehicles are not allowed off existing roads that are open to the public, unless otherwise specified within this permit. Permittee parking shall not block traffic or impede fire or emergency vehicles.
- Designated Wildlife Trees or any trees marked with orange paint must not be cut.
- Stumps shall be cut at or below a height of 6 inches. Trees shall be limbed to a 4-inch diameter top. Slash and unused vegetative matter resulting from Permittee's activities shall be scattered to a depth of less than 12 inches and shall not be left in piles or scattered on trails, roads, ditches, or stream channels.
- Firewood cut and/or collected under this permit shall be cut into lengths of eight (8) feet or less prior to removal.
- Permittee shall remove all trash and litter resulting from permittee's activities.
- Do not smoke in the gathering area.
- The Forest Service and/or BLM reserve the right to unilaterally revoke this permit for permittee's noncompliance with its terms and conditions or when revocation is in the public's interest.
