Clark Fork River Area (south side of the river)



OVERVIEW

The Trout Creek National Recreation Trail (NRT) #774 is a 19.8 mile loop trail located in the Trout Creek Roadless Area. The trail makes a large loop, following the East Fork of Trout Creek, Idaho/Montana border, South Branch of Trout Creek, and the West Fork of Trout Creek. Numerous Forest System trails and open roads intersect the trail in various locations allowing for a variety of loop hiking options. Most visitors access the trail from the trailhead for the Trout Creek NRT #774 located at the end of Hope Valley Road/FSR 214.

DIFFICULTY

More difficult

FACILITIES

The trailhead for the Trout Creek NRT #774 is located at the end of FSR 214. The trailhead has a few dispersed campsites located along Trout Creek. Be advised FSR 214 is very rough and only suitable to high clearance vehicles. Most stock users park at the Black Peak Trail #763 trailhead (junction of Hope Valley Road and Trout Creek Road) and ride Hope Valley Road/FSR 214 to the trailhead.

DIRECTIONS

From Trout Creek travel west on Pine Street for approximately 1.5 miles. Turn south on Trout Creek Road. Travel approximately 3 miles and turn west onto Hope Valley Road. Follow Hope Valley Road 1.5 miles until it turns into FSR 214. The trailhead is at the end of FSR 214.

TRAIL CONDITIONS

Trout Creek NRT #774 is a Trail Class 3 trail. The trail tread and corridor will be very well defined and visible. The trail is scheduled to be cleared every year. Please contact Cabinet Ranger Station for current trail conditions.
