LEGAL NOTICE MT. HOOD NATIONAL FOREST: DRAFT DECISION NOTICE FOR ENVIRONMENTAL ASSESSMENT. The North Clack Integrated Resource Project is located in T.4 S., R.5 E.; T.4 S., R.6 E.; T.4 S., R.7 E.; T.5 S., R.6 E.; WM, Clackamas County, Oregon. The proposed alternative includes approximately 4,219 acres of thinning, 341 acres of regeneration harvest, construction and reconstruction of 19.4 miles of temporary roads, fuel treatments, road closures, and other restoration projects. The Environmental Assessment and Draft Decision Notice can be downloaded from the Forest website at <http://www.fs.usda.gov/projects/mthood/landmanagement/projects>. The Responsible Official is Jackie Groce, District Ranger, Clackamas River Ranger District. This draft decision is subject to objection pursuant to Forest Service regulations at 36 CFR 218. Only individuals or organizations that submitted specific written comments during a designated opportunity for public participation (scoping or the 30-day public comment period) may object (36 CFR 218.5). Notices of objection must meet the requirements of 36 CFR 218.8. Objections must be filed with the Reviewing Officer within 45 days from the date of publication of notice of the opportunity to object in The Oregonian. The publication date is the exclusive means for calculating the time to file an objection. The Objection Deciding Officer is the Forest Supervisor. An objection should be addressed to the Forest Supervisor at any of the following addresses. For postal delivery, mail to: Forest Supervisor, Objection Reviewing Officer, Mt. Hood National Forest, Zigzag Ranger Station, 70220 E. Highway 26, Zigzag OR 97049. Hand deliveries at the address above can occur between 7:45 AM and 4:30 PM (closed 12:00 to 1:00), Monday through Friday except legal holidays. Objections may be emailed to: objections-pnw-mthood@usda.gov. Electronic objections must be submitted as part of the actual e-mail message, or as an attachment in Microsoft Word (.doc), rich text format (.rtf), or portable document format (.pdf) only. E-mails submitted to email addresses other than the one listed above, or in formats other than those listed, or containing viruses, will be rejected. It is the responsibility of the objector to confirm receipt of objections submitted by electronic mail.
