On 10.12.18, I had a telephone conversation with Jeff Feldpausch, Resource Protection Director, Sitka Tribe of Alaska. We discussed three topics as noted below.

Government-to-Government Consultation

Sitka Tribe will follow-up on preferred date for government-to-government consultation. There was some confusion at “what level” the consult will occur. Perry Edwards, indicated to the tribe, that the district would carry out the consultation – and, it sounded like the Tribe preferred consult with USFS leadership on the roadless rulemaking project. I indicated the Forest Service is flexible, but that generally the district rangers are attending consultations, among additional USFS leadership.

10/15/18 Comment Deadline

Sitka Tribe will submit written comment by deadline via email.

Cooperating Agency

Sitka Tribe will continue discussing cooperating agency status among themselves. There might have been some confusion between the USFS and SOA processes. The letter requesting cooperating agency status may have been sent to the USFS without due internal deliberations. I indicated the Forest Service remains on standby for further conversation.
