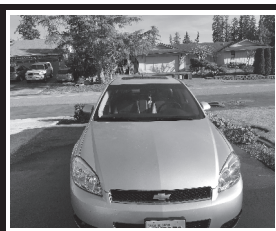

#### REQUEST FOR COMMENTS USDA Forest Service Mt. Baker Ranger District Whatcom County, Washington Excelsior Mine Plan of Operations Project

The Draft Environmental Assessment (DEA) for the proposed Excelsior Mine Plan of Operations project is available for review and comment. Project implementation would authorize the restoration, use, and maintenance of an existing non-system temporary road within the Mt. Baker (north) Inventoried Roadless Area. In addition, the project would authorize mine maintenance and underground sampling. The site is located in Whatcom County in the Mt. Baker Ranger District, approximately 6 miles east of Glacier, Washington. The Responsible Official for this project is District Ranger Erin Uloth. The DEA and other information are available on the Forest's website at: <https://www.fs.usda.gov/project/?project=43458>; at the Mt. Baker District office; and from the project team leader (contact information below). The Forest's website is the primary source of information about the project. Comments on the DEA will be accepted for 30 days following publication of this legal notice. This publication date is the exclusive means for calculating the comment period.
