GENERAL CONTROL OBJECTIVES

Leader's Intent

- Commit resources only when there is a reasonable expectation of success in protecting life and critical property and infrastructure. Effectively implement a values-driven strategy that utilizes a mix of tactics (direct, indirect, and point-protection) when and where the probability of success is high, and the risk is commensurate with the identified values. Success is defined as safely achieving objectives with the least firefighter exposure necessary while enhancing stakeholder support and adhering to the core values of conservation, interdependence, and service.
- Utilize COVID-19 SOPs and risk mitigation practices including San Carlos Apache Tribe's COVID-19 Orders.
- Ensure Planning Area encompasses Federal lands under the jurisdiction of the Tonto National Forest and San Carlos Agency, as well as lands under the jurisdiction of the State of Arizona.

Values at Risk

- Incident personnel and the public
- Communities of concern to include Roosevelt, Rock House, Qual Run, Spring Creek Ranch, Wheatfields, Globe, Miami/Claypool. Properties and infrastructure to include APS/SRP kV Transmission Lines, local utilities/powerlines, Pinto Valley Mine, Freeport McMoRan Mine, BHP Mine, Carlotta Copper Mine, Range Infrastructure and Upper Horrell Ranch.
- San Carlos Agency values at risk include: Ceremonial site at Upper Highway Tank, Range improvements including fence lines and water developments. San Carlos Commercial Timber Stands and Carol Spring Communication Site.
- Major transportation corridors to include Hwy 188, Hwy 288, and U.S. 60/77
- Salt River Canyon and Superstition Wilderness characteristics and values
- Sonoran Desert vegetation and ecological communities (minimize the potential spread of noxious weeds)
- Airshed and smoke sensitive areas to include Globe and surrounding communities
- Archeological and cultural resources and sites
- Wildlife Resources to include threatened and endangered species habitat to include Mexican spotted owl, narrow headed and northern Mexican garter snakes, razorback sucker, southwestern willow flycatcher and Yellow Billed Cuckoo
- Relationships with cooperators, stakeholders, and the public in impacted areas

Incident Objectives

- Provide for the safety of incident responders and the public through the application and implementation of sound risk management, to include planning and conducting fire operations to minimize impacts and spread of COVID-19.
- Values are communicated and protected from adverse fire and incident management actions.
- Foster and strengthen relationships between incident agencies, partners, cooperators, responders, and communities in impacted areas.
- Provide timely and accurate information to the public and media on the fire status and incident activities.
- Minimize impacts to properties and infrastructure.
- Protect identified archeological, historic, and natural resources.
- Engage the host agencies and resource advisors to effectively protect values and minimize impacts.
- Effectively manage incident costs through the selection and implementation of strategies and tactics that have a high probability of success in meeting objectives.
- Manage timely, safe, and efficient initial attack within the TFR. Coordinate with local agencies and support initial attack outside the TFR.

Incident Requirements

- Resources will maintain a "module of one" separation. Masks will be required when meeting in groups outside of your "module of one" and when interacting in close proximity (< than 6') with individuals outside your "module of one."
- Include San Carlos Agency Management, San Carlos Tribal Council, Tribal Members and Neighboring agencies included in your regular dissemination of fire information.
- Create and maintain a work environment in which people are treated with respect and dignity.
- Coordinate and document planned actions. Document use and intrusions in the wilderness.
- Notify the public in advance when smoke has the potential for a significant impact to smoke sensitive areas. If Agency Administrators have not responded to fire information within 30 minutes of receiving the news release for review, the news release will go out.

Resource Considerations:

- Work with Lead Resource Advisor regarding resource considerations.
- Work with Director of Wildlife and Recreation for Law Enforcement Coordination.

INPUTS

WEATHER SUMMARY: T-storm development remains less likely today, but still a possibility. Humidity recovery was expected to be better last night with recoveries 52-75%. Continued chances for late afternoon to mid-evening isolated thunderstorms. Impacts from isolated storms will include very gusty outflow winds, possible lightning, and brief heavy downpours.

Sky Condition: Mostly sunny **Temp:** 93-99° **Humidity (min):** 27-34% **Chnc of Precip:** 20%

OUTPUTS

FIRE BEHAVIOR

GENERAL:

Summary – Better overnight humidity recovery will likely delay fire activity transitioning from creeping to active fire movement. Expect the transition to begin in mid-slope grasses between 1100 and noon before general fire activity picks up in the afternoon. In the mid to late afternoon, watch for cells building over the Mogollon Rim to the north because of **outflow winds** which will drastically and quickly increase fire behavior.

Environment –ERCs are running at, or near, the 95th percentile due to lack of a traditionally robust monsoon in July. This is an unusually hot and dry period for late August and fuels are much more receptive to ignition than normal.

Fuels – Sonoran Desert/Desert Grasslands – Fully cured heavy grass crop, including invasive grasses have resulted in a continuous available fuel bed allowing fire to sustain growth even in the absence of strong winds or steep terrain.
- Upper shrublands - Expect all fuels to be available with live FM in the mid 50-70% range for Oak and Manzanita. Mesquite and juniper clumps often contain continuous grasses and torch easily contributing embers for, generally short-range, spot fires.

General fire characteristics – Conditions represent active fire behavior based on predicted afternoon conditions.

GRASS Head Fire – ROS: 25-50 ch/hr; FL 2-4 ft, **Backing/Flanking Fire** ROS – 1-3 ch/hr, FL-1-3 ft
GRASS-BRUSH Head Fire – ROS: 15-35 ch/hr; FL 5-8 ft, **Backing/Flanking Fire** ROS – 2-10 ch/hr, FL-2-4 ft
BRUSH Head Fire – ROS: 5-20 ch/hr; FL 8-15 ft, **Backing/Flanking Fire** ROS – 1-3 ch/hr, FL-4-8 ft
TIMBER LITTER Head Fire – ROS: 1-4 ch/hr; FL 1-4 ft, **Backing/Flanking Fire** ROS – 1-2 ch/hr, FL-1-2 ft

SPECIFIC:

Salt Fire – Major fire growth will continue to flank along Pinto Creek towards Blevens Wash with the greatest growth potential in Granite Basin and Gerald Hills. Westerly winds will aid in limiting growth on the western flank, but consistent fuels and topography aligned with westerly winds will allow fire to push rapidly in the early afternoon towards Hwy 188.

Griffin Fire – Fire is on both sides of Hwy 60. Primary growth will likely be on the southeastern flank of the fire with growth east past Sevenmile Wash and likely past Sevenmile Mountains towards Brushy Basin. Expect rapid rates of spread as rising topography east of Sevenmile Wash will funnel the westerly winds and accelerate fire.

Gin Fire – Expect fire to continue east towards the heel of the Griffin Fire. Areas of heavy fuels exist in a valley between the two fires along FS584A. When fire reaches this area, expect a rapid increase in activity with group torching and sustained runs to the east.

AIR OPERATIONS:

Hazy conditions in the morning may limit aviation effectiveness, but condition should improve after 1100.

SAFETY – Transitions

Watch for changing conditions – slope reversals, fuel type changes, and shifting/increasing winds. These all indicate a high probability in rapidly changing fire behavior. Observe and plan accordingly before engaging.

Discussion

Saturday appears to be somewhat more active across the Mogollon Rim into southern Gila County with more typical isolated to scattered thunderstorm coverage. The timing of peak thunderstorm activity on Saturday appears to be after 3 PM. Overnight humidity recovery should be good - between 55 and 70 percent - before bottoming out again between 25 and 30 percent on Saturday afternoon. Breezy west winds also continue for most of Saturday with occasional afternoon gusts of 25-30 mph.





NARRATIVE:

Don't Be Surprised in the Southwest!

Mid-June through early July in the Southwest has historically been the peak of fire season, fire behavior potential, and associated risk of injury or death to fire management personnel. This has been proven over the years, with dozens of firefighter fatalities, injuries, entrapments and close calls occurring within this time frame. 2020 has proven to be an exception to our normal historical range of large fire occurrence with multiple mid-August fires currently burning in the desert southwest.


The following conditions are to be expected and incorporated into all aspects of wildland fire management:

- **Extreme Heat and Dryness:** Mostly sunny, with a high near 98. Breezy, with a west wind around 15 mph, with gusts as high as 25 mph. Excessive Heat Watch in effect from August 24, 10:00 AM MST until August 27, 08:00 PM MST
- **Environment:** ERCs are running at, or near the 95th percentile due to lack of traditional monsoon in July. This is an unusually hot and dry period for late August and fuels are much more receptive to ignition than normal
- **Prolonged Active Burning Periods:** Combination of heat, heavy fine fuel loading, dryness and instability will prolong active burning periods noticeably.
- **Strong and Erratic Thunderstorm Winds:** Thunderstorm activity *will* become a factor on most Southwest fires during this time frame, and resulting strong & erratic downdraft winds should be expected to potentially dominate fire spread & behavior. Actively seek information on storm movement (speed and direction) to facilitate risk assessment.
- **Collapsing Convection Columns:** The periodic collapse of strong convection columns over ongoing fires can create downdraft winds similar to those of stationary thunderstorms, with similar dangerous impacts on fire spread and behavior.
- **Heavy Fine Fuel Loading:** The southern portion of the Geographic area has a heavy fine fuel loading; which will be a factor in RAPID FIRE GROWTH,

Fires exhibiting high resistance to control and rapid spread events are normal in the Southwest during peak fire season, and impacts will be amplified during periods of record heat. Plan, communicate, and act accordingly!
