Footnotes:

1. Carryover BA at start of FY is adjusted in this report due to rounding to additional decimal places; State and Private Forestry and Wildland Fire Management accounts reflect a shift in prior year programs that moved between the accounts.
2. Other BA includes Transfers, Adjustments, Cost Pool Assessments and Recoveries
3. Negative Expended/Unexpended or committed/uncommitted amounts reflect the spending chain, moving from unexpended to expended or uncommitted to committed.
4. National Forest System (NFS) - Payroll Default Accounting (DFAC), Disaster Fund Supplemental (NFDD), Payroll Force Release (NPFM), Travel Relocation Taxes (TVTX), and Uniform allowance (UNAW) functional areas are excluded from this report.
5. Deficit unobligated balance in Forest and Rangeland Research is due to expenditures which occurred while under the Continuing Resolution that are pending allocation to the appropriate program area.
6. Mandatory account Budget Authority reflects receipts collected.

Discretionary unobligated balance includes FLAME funds which are available under specific guidelines; the Wildland Fire Management Preparedness balance includes \$65 million reserved for acquisition of an air tanker. In the Mandatory accounts, the Restitution of Improvements line includes \$200 million in Tronox settlement funds which have a 50 year spending plan.
