FOREST SERVICE REPROGRAMMING REPORT FOR FY 2012

Summary of All Reprogramming Requests Approved in FY 2012

1. Savings in the amount of \$1,000,000 in Fiscal Year (FY) 2012 Land Acquisition funds from the Shield Ranch project on the Coconino National Forests in Arizona to the FY 2012 Acquisition Management account.
2. Savings from the Big Horn Mine property in the FY 2010 Land Acquisition funding on the Angeles National Forest in the amount of \$1,750,000 to be used for the Big Sur Ecosystem project in the FY 2010 Land Acquisition program.
3. Savings in the amount of \$600,000 in FY 2010 from the Bear Creek Ranch land acquisition on the Gila National Forest in New Mexico and \$85,000 in FY 2010 from the Cummings Tract land acquisition on the Monongahela National Forest in West Virginia reprogrammed to FY 2010 Tenderfoot project on the Lewis and Clark National Forest in Montana.
4. Savings in the amount of \$500,000 in FY 2007 Capital Improvement and Maintenance funds from the Santa Clara Mohave District will be used for critical recreation maintenance in Region 5.
5. Savings in the amount of \$48,548 from the FY 2012 Land and Water Conservation Funds High Uintas/Anadarko project completed March 29, 2012, will be used to complete the third and final phase of the Castle Valley property.
6. Savings of \$150,000 on the Plains Water System Replacement project on the Lolo National Forest in Region 1 funded from FY 2012 Deferred Maintenance and Infrastructure funding, to the Red River Water and Wastewater Replacement Project on the Nez Pierce National Forest in Region 1, an approved FY 2011 Capital Improvement and Maintenance Facilities Project.
