This letter is in response to the reprogramming requirement in the Joint Explanatory Statement, Division G for the Fiscal Year (FY) 2018 Consolidated Appropriations Act, H.R., 1625.

As of the third quarter, which ended June 30, 2018, the U.S. Department of Agriculture's Forest Service has requested to reprogram \$1,535,000 from Land and Water Conservation Fund (LWCF) projects. The Agency did not request reprogramming for other eligible programs or funds, nor did the agency reprogram funds per Chief's authority below the monetary thresholds.

Two actions were approved.

1. Reprogrammed the \$927,000 remaining balance derived from cost savings from FY 2016 LWCF for three different Land Acquisition projects:
 - \$351,000 from the Great Lakes Northwoods (Michigan) project to the El Dorado National Forest for the Forni Meadows-Sierra Nevada Checkerboard acquisition;
 - \$330,000 from the Pacific Northwest Streams (Oregon) project to the El Dorado National Forest for the Forni Meadows-Sierra Nevada Checkerboard acquisition;
 - \$246,000 from the Fossil Creek (Arizona) project to the Tonto National Forest for the Doll Baby Ranch acquisition.
2. Reprogrammed \$608,000 from the 2018 LWCF project on the Flathead National Forest (Montana) to the Lolo National Forest in Montana for the Edith Peak acquisition.




