### FOREST DEVELOPMENT ROADS

#### **PROHIBITIONS:**

Pursuant to Title 36 CFR 261.50(b) the following act is prohibited on the Forest Development Roads described this order, all within the Beaver Ranger District, Fishlake National Forest between January 1 and July 15, annually or until road bed is sufficiently dry.

1. Using any type of vehicle prohibited by the Order (36 CFR 361.54(a)). Prohibition includes any type of vehicles, <u>except</u> over-snow vehicles and vehicles with a wheel base less than 60 inches wide.

### **EXEMPTIONS:**

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

- 1. Persons with a permit specifically exempting them from the effect of this Order.
- 2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
- 3. Federal or State administrative personnel in the performance of an official duty.

# **ROADS DESCRIPTION:**

KENTS LAKE ROAD #137- From the gate above Upper Kents Lake east to the gate at LeBaron Lake.

#### **PURPOSE:**

This Order will remain in effect from January 1 to July 15 annually, as <u>long as the road is barricaded or gates are locked closed</u>, which is until such time prolonged favorable weather conditions make the road suitable for travel, without undue damage when wet or saturated with moisture.

## **DEFINITION:**

Over-snow vehicle. A motor vehicle that is designed for use over snow and that runs on a track or tracks and/or a ski or skis, while in use over snow 36 CFR 212.1.

### **IMPLEMENTATION:**

- 1. This Order will be in effect when signed and shall remain in effect until further notice.
- 2. A list of roads identifying the closed roads is attached and made part of this Order.
- 3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000.00 for an individual or \$10,000.00 for an organization, and/or imprisonment for not more than six (6) months. [Title 16 USC 551, Title 18 USC 3571(b) (6), Title 18 USC 3581 (b) (7)].
- 4. Further information regarding this Order may be obtained at the Beaver Ranger District Office, (435) 438-2436.
- 5. This Order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order on the roads covered by this Order.
