

SPECIAL ORDER
WILDERNESS LAKE RESTRICTIONS
PAYETTE NATIONAL FOREST

Pursuant to Title 36 CFR Sec. 261.50 (a), the following acts are prohibited on the area described below in the Frank Church-River of No Return Wilderness within the Payette National Forest until further notice.


- (1) Camping, except at designated sites. 36 CFR 261.58 (e)
- (2) Camping for more than three nights within any 30 day period at each lake. 36 CFR 261.58(a)
- (3) Camping by more than eight persons per designated site. 36 CFR 261.58(f)
- (4) Holding or grazing of pack and saddle stock except at a designated site as posted. 36 CFR 261.58(aa).

Pursuant with 36 CFR 261.50(e), the following persons are exempt from this order.

Persons with a permit specifically authorizing the otherwise prohibited act or omission.

Area described

Within 61 meters (200 feet) horizontal distance from the high water mark of the lakes described in Exhibit 1 and identified on the attached maps.

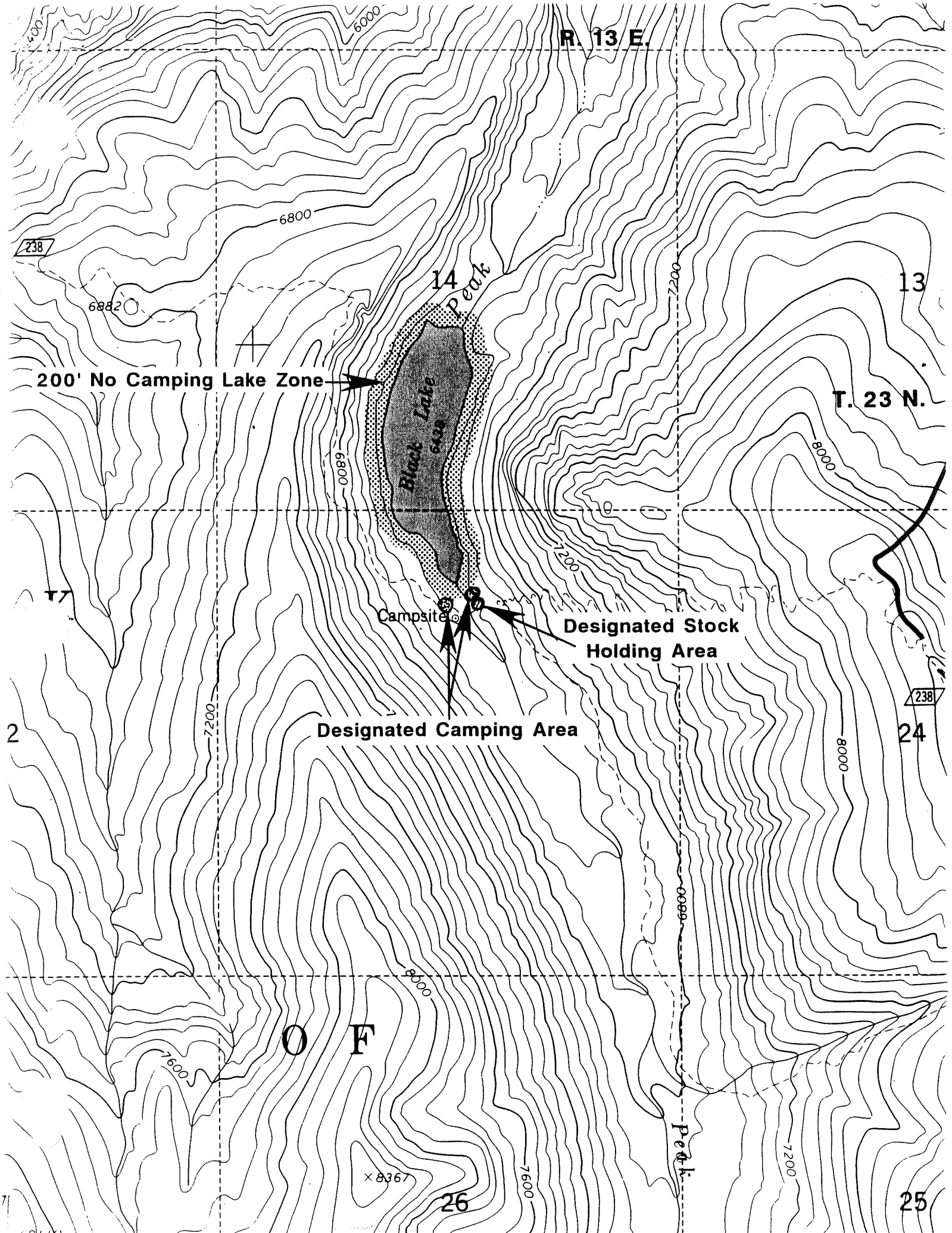
Violation of these prohibitions is punishable by a fine of not more than \$5000.00 or imprisonment for not more than 6 months or both. (16 U.S.C. 551)

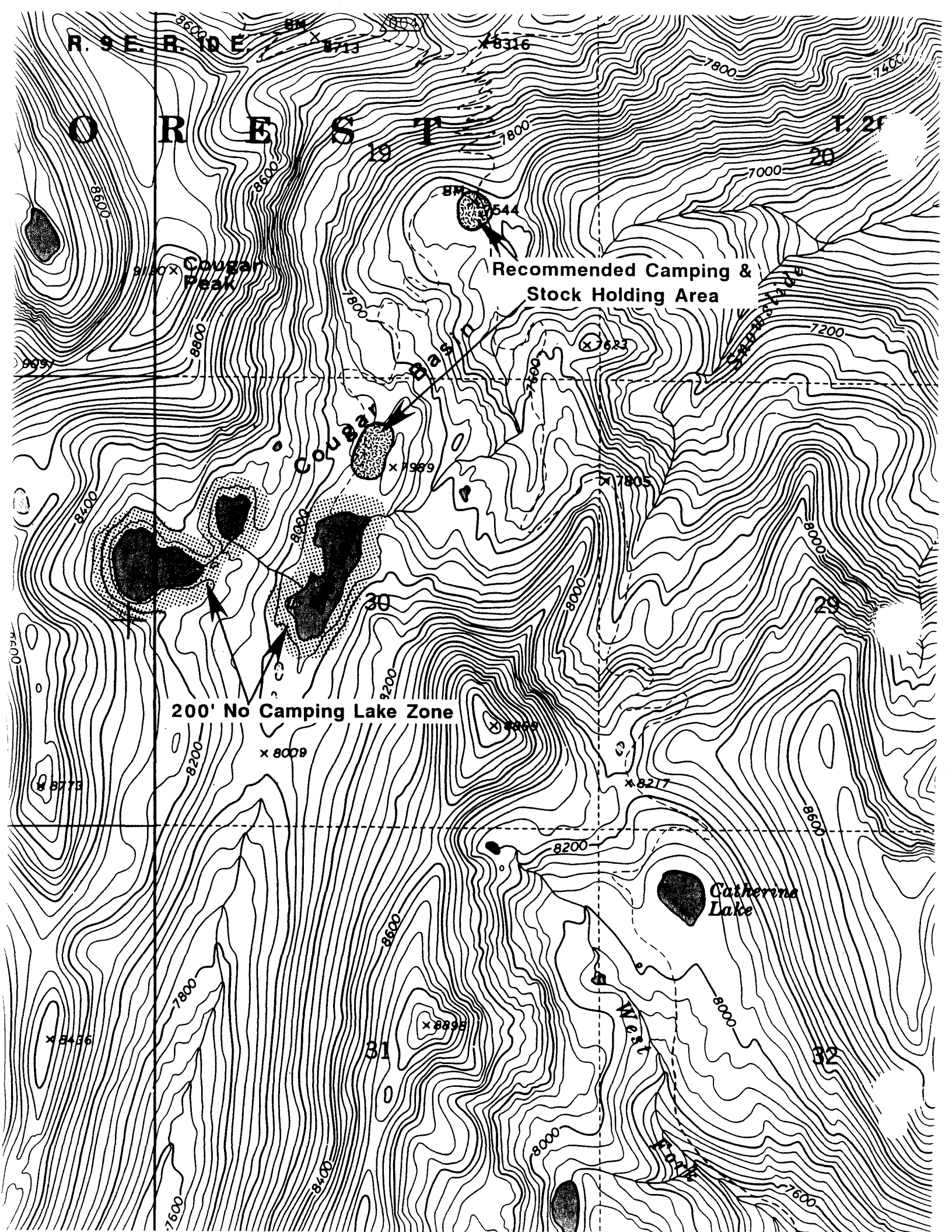

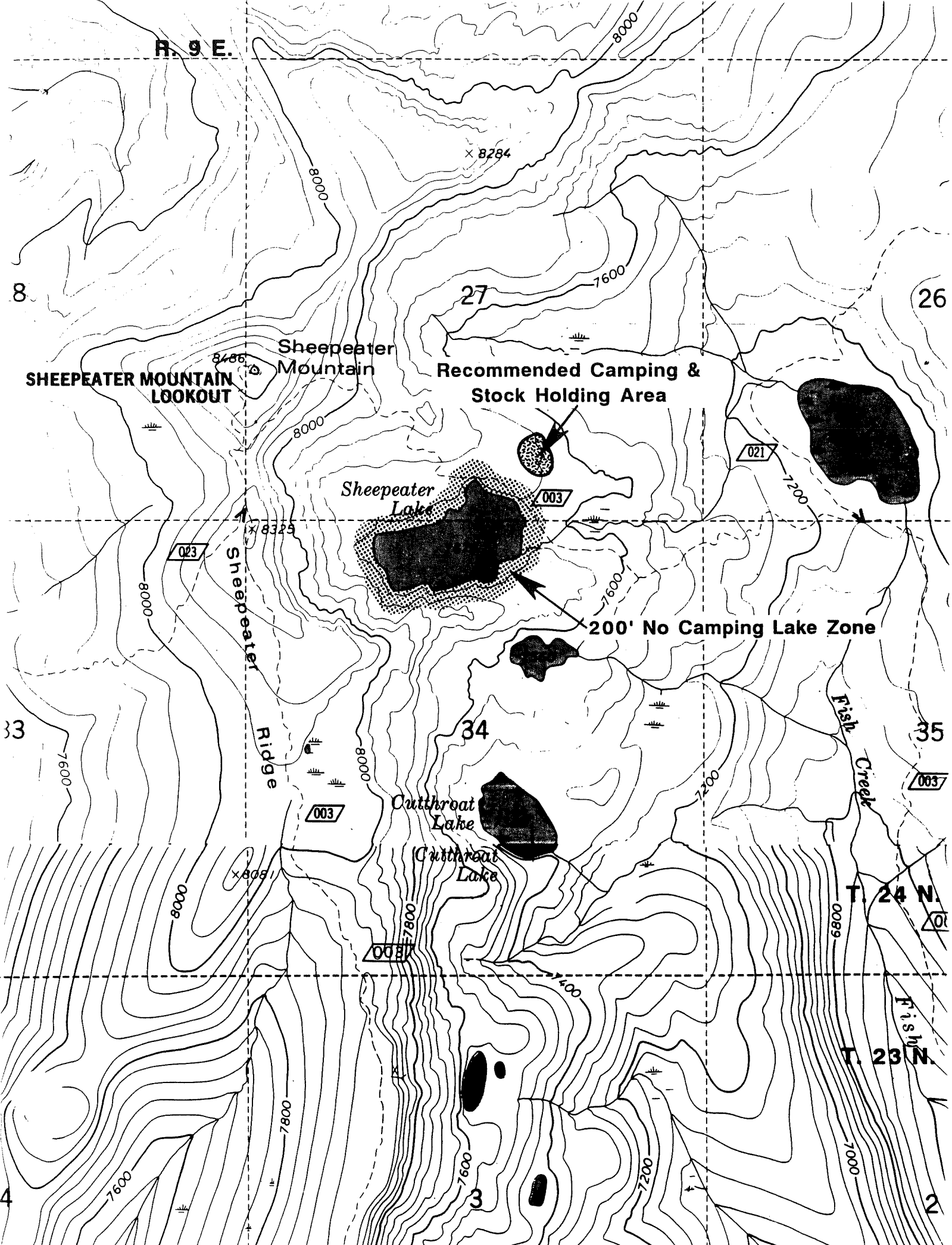

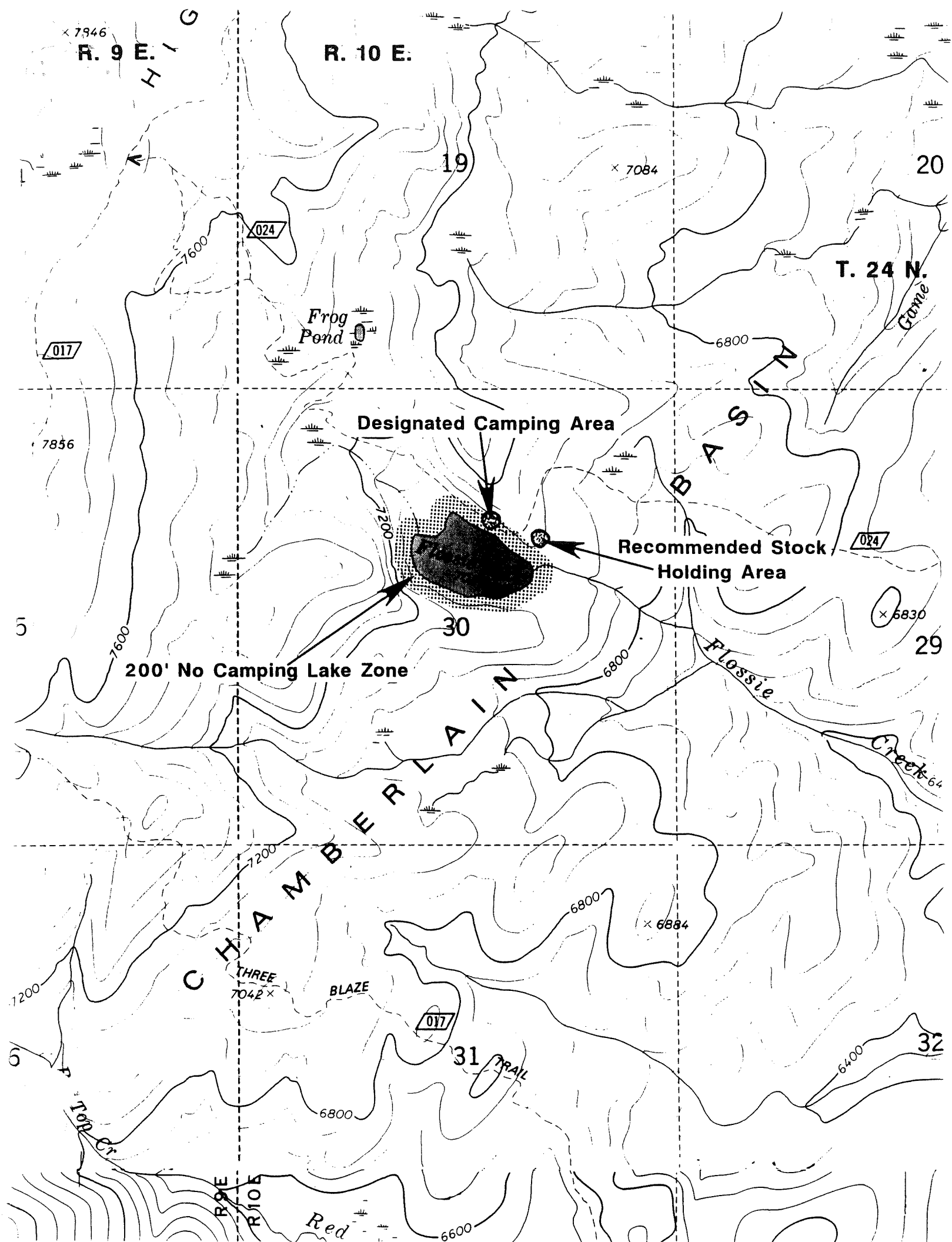
