

Forest Order No. 03-25-01
USDA Forest Service
Eldorado National Forest
Silver Bear Snowmobile Trail Wheeled Vehicle Closure

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(b), and to provide for public safety and protect natural resources, the following acts are prohibited within the Amador Ranger District of the Eldorado National Forest. This Order is effective from February 14, 2025, through December 15, 2026.

1. Using a motorized wheeled vehicle on a National Forest System Road within the Silver Bear Snowmobile Trail System, as shown on Exhibit A and listed in Exhibit B, when the snow depth for the area reaches 1 inch" according to the California Nevada River Forecast Center daily snow depth summary as shown on Exhibit D. 36 C.F.R. § 261.54(a).
2. Using a motorized wheeled vehicle on a National Forest System trail within the Silver Bear Snowmobile Trail System, as shown on Exhibit A and listed in Exhibit C, when the snow depth for the area reaches 1 inch" according to the California Nevada River Forecast Center daily snow depth summary as shown on Exhibit D. 36 C.F.R. § 261.55(b).

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
2. Any Federal, State or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

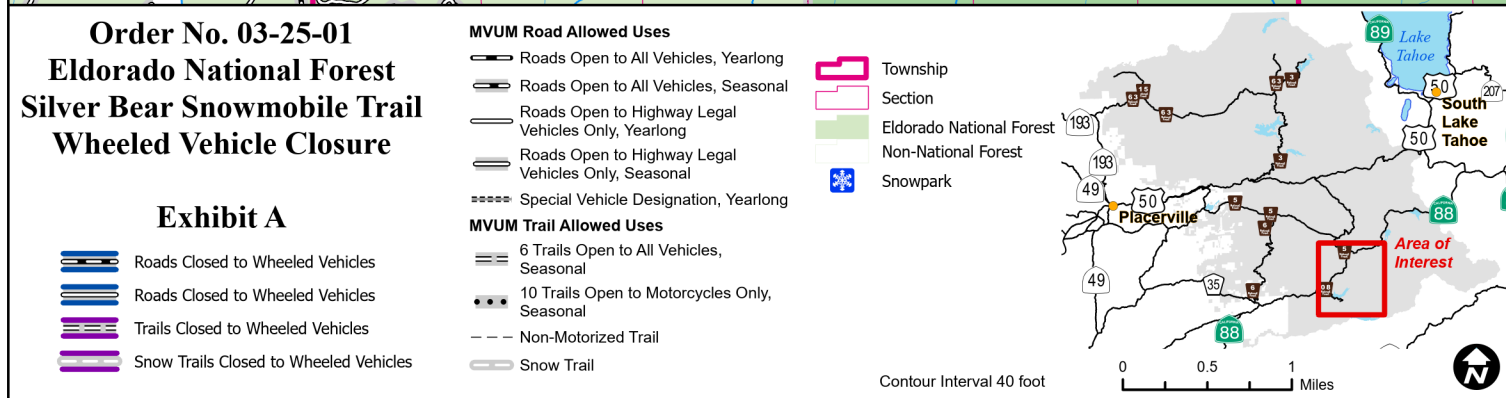
These prohibitions are in addition to the general prohibitions listed in 36 C.F.R. Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571 and 3581.

- c. **Forest Road No. 09N02** - Starting from its intersection with Forest Road No. 09N14 to its intersection with Forest Road No. 09N02A.
- d. **Forest Road No. 09N02A** - Starting from its intersection with Forest Road No. 09N02 to its end.
- e. **Forest Road No. 09N24C** - Starting from its intersection with Forest Trail No. 16E43 to its intersection with Forest Road No. 09N24.
- f. **Forest Road No. 09N24** - Starting from its intersection with Forest Road No. 09N24C to its intersection with Forest Road No. 08N31.
- g. **Forest Road No. 08N31** - Starting from its intersection with Forest Road No. 09N24 to its intersection with Forest Road No. 08N18.
- h. **Forest Road No. 08N18** - Starting from its intersection with Forest Road No. 08N31 to its intersection with Forest Road No. 08N21.
- i. **Forest Road No. 08N21** - Starting from its intersection with Forest Road No. 08N18 to its intersection with Forest Trail No. 16E47.
- j. **Forest Road No. 08N20** - Starting from its intersection with Forest Trail No. 16E47 to its end.
- k. **Forest Road No. 08N16** - Starting from its intersection with Forest Road No. 08N15 to its intersection with Forest Road No. 08N40.
- l. **Forest Road No. 08N40** - Starting from its intersection with Forest Road No. 08N16 to its intersection with Forest Road No. 08N14.
- m. **Forest Road No. 08N14** - Starting from its intersection with Forest Road No. 08N40 to its intersection with Forest Road 08N12.
- n. **Forest Road No. 08N12** - Starting from its intersection with Forest Road No. 08N14 to its intersection with Forest Road No. 08N15.
- o. **Forest Road No. 08N15** - Starting from its intersection with Forest Road No. 08N12 to its intersection with Forest Road No. 08N15A.
- p. **Forest Road No. 08N03** - Starting from its intersection with Forest Road No. 08N14 to its intersection with Forest Trail No. 16E26.
- q. **Forest Road No. 09N35** - Starting from its intersection with Forest Trail No. 16E44 east of Forest Road No. 09N35 to its intersection with Forest Trail No. 16E44 west of Forest Road No. 09N35.

- c. **Forest Trail No. 16E44** - Starting from its intersection with Forest Road No. 09N35 to its intersection with Forest Road No. 10N50
- d. **Forest Trail No. 16E47** - Starting from its intersection with Forest Road No. 08N20 to its intersection with Forest Road No. 08N21.
- e. **Forest Trail No. 16E26** - Starting from its intersection with Forest Road No. 08N03 to its intersection with Forest Trail No. 16E44.
- f. **Forest Trail No. 16E44** - Starting from its intersection with Forest Trail No. 16E26 to its intersection with Forest Trail No. 17E24.
- g. **Forest Trail No. 17E24** - Starting from its intersection with Forest Trail No. 16E44 south of Forest Trail No. 17E24 to its intersection with Forest Trail No. 16E44 north of Forest Trail No. 17E24.
- h. **Forest Trail No. 16E44** - Starting from its intersection with Forest Trail No. 17E24 to its intersection with Forest Road No. 09N35.
