The following area is closed within the Superior National Forest are based on Forest Order 09-09-25-05 for the Brimson Complex Fire. This Forest Order Closure applies to all trails and roads within the area, areas crossed out are now open:

- ~~From FR 130 (Moose line Rd) South to St. Louis County Road 16~~
- ~~From St. Louis County Road 16 East to FR 118 (Camp 26 Truck Trail)~~
- ~~From FR 118 South to Forest Boundary by the South Branch of the Whiteface River~~
- ~~The Forest Boundary constitutes the majority of the Southern border of the closed area~~
